Rental Assistance:

Federal Funding - CARES Act

- Basic Needs Supplemental Funding (\$20 Million)
- > CDBG (\$8.35 Million total; \$7.9 Million for rent assistance)

State Funding - CARES Act

Virginia Rent and Mortgage Relief Program (\$1.68 Million for Fairfax)

County Funding - Consolidated Community Funding Pool (CCFP)

CCFP (Approx. \$5 Million designated for Basic Needs)








Eviction Prevention Access to Resources & Outreach Efforts

Access to Eviction Prevention Resources


- Residents call Coordinated Services Planning


