New Business

1. Taxicab Certificates and Rates. Steve Sinclair, Chief, Public Utilities Branch, provided an overview of the history of certificates over the last ten years, staff's recommendation, rules governing taxicab rates, and the public hearing on October 18, 2011.

Chairman Fee moved that the Consumer Protection Commission recommend to the Board of Supervisors that the number of taxicab certificates remain at 576 for the period 2011 to 2012. Commissioner Bounacos seconded the motion. The motion passed unanimously.

2. Falls Church Water Study. Susan Hafeli, Utilities Analyst, Public Utilities Branch, presented the

Falls Church Rate Study: Preliminary Considerations. The slide presentation showed the prior CPC /Board action, 2010 Court Directive, Board's 2011 issues, remaking principles, first principle, second principle, proposed operation & maintenance reserve, proposed repair, rehabilitation, and replacement reserve, proposed debt service reserve, selected reserve adjustments, third principle, operation

& maintenance water administration, source of supply, selected adjustments, consumption estimates, system expansion funding, cash balances, fourth principle, fifth principle, sixth principle, seventh principle, and the preliminary rate study issues.

Chairman Fee moved that the Consumer Protection Commission recess and go into closed session for discussion and consideration of matters enumerated in Virginia Code Section § 2.2-3711 as follows:

Consultation with legal counsel and briefings by staff members or consultants pertaining to actual or probable litigation, and consultation with legal counsel regarding specific legal matters requiring the provision of legal advice by such counsel pursuant to Virginia Code Section § 2.2-3711(A)(7); specifically to include the case of *Board of Supervisors v. Fairfax County, et al. v. City of Falls Church; Case CL-2010-18232.* The motion was seconded by Commissioner Nguyen. The motion was passed unanimously.
