Defendant Amber Heard brings this motion for sanctions against Plaintiff's counsel Adam Waldman for his repeated abuse of the discovery process, violation of the Court's Protective Order, and general conduct in this case.<sup>1</sup> Throughout this litigation, Mr. Waldman has acted like anything but an attorney this Court has a right to expect. Defendant now responds to this Court's multiple invitations to address the conduct directly through a motion for sanctions against Mr. Waldman, including the revocation of his *pro hac vice* admission, prohibition from further contact with the press or the public through social media about this case, and for fees and costs for having to bring this motion.

## ARGUMENT

### I. Legal Standard

The Supreme Court of Virginia “has recognized that the courts of this Commonwealth have the inherent power to supervise the conduct of attorneys practicing before them and to discipline any attorney who engages in misconduct.” *Nusbaum v. Berlin*, 273 Va. 385, 399 (2007) (citations and quotations omitted). This includes the power “to remove an attorney of record in a case[.]” *Id.* With respect to attorneys admitted *pro hac vice*, the Virginia Supreme Court has held that “Virginia courts have broad discretion in determining whether to revoke an attorney’s *pro hac vice* admission. A court may revoke the *pro hac vice* admission of counsel at any stage of court proceedings when it appears that counsel’s conduct adversely impacts the administration of justice.” *Williams & Connolly, LLP v. PETA*, 273 Va. 498, 522 (2007). “Admission *pro hac* [vice] is not a right, it’s a courtesy and a privilege[.]” *Id.* (quoting Circuit

Court decision). Revocation is within the Court's authority and is appropriate when counsel's conduct reflects an "inadequate understanding of Virginia's ethical requirements" or fails to meet "the level of professionalism . . . that our [C]hief [J]ustices. . . as well as many others in the [S]tate have worked so hard to instill." *Id.*; *see also Myer v. All Dulles Area Muslim Soc'y*, 102 Va. Cir. 77, 78 (Fairfax Cty. 2019) (citing *Williams & Connolly*) (contemptuous and disparaging language is inherently improper and subject to sanction under the statute.). Mr. Waldman has crossed the line of decorum and conduct expected of counsel in numerous ways.

## **II. Mr. Waldman has Violated the Protective Order**

On at least two occasions, Mr. Waldman has violated the Court's Protective Order in this case by leaking documents marked "Confidential" to the press. The first was the deposition testimony of Joshua Drew, a third-party witness in this case. On June 10, 2020, Defendant's representatives received an email from a publication referencing Drew's deposition testimony and alleged testimony regarding a rumor (which is untrue) relating to Defendant's relationships.

**Exh.1.** Because that portion of the deposition transcript had been marked Confidential, counsel for Defendant promptly reached out to Mr. Chew and demanded the leak be retracted. **Exh. 2.** Mr. Chew did not respond, though in a later telephone conversation with Defendant's counsel, did not deny that Mr. Waldman had leaked the transcript. It thus came as no surprise when, just a few weeks later, another press organization reported on a text message between Defendant and Elon Musk that had been marked "Confidential" yet leaked to the press and tweeted by Mr. Waldman, in further violation of the Protective Order. **Exh. 3.**

It is no rebuttal for Plaintiff to contend that the leaked material should not have been designated as Confidential under the Protective Order. The Protective Order provides a mechanism for a claim of over-designation: the parties are to meet and confer promptly to

resolve disputes and, if necessary, may request the Court remove or modify a confidentiality designation. 9/25/19 Protective Order § II(2). Indeed, Plaintiff's counsel referred to this provision during the Joshua Drew deposition when Defendant's former counsel claimed Mr. Depp had over-designated portions of the deposition and Mr. Chew replied: "We have the right to designate, and you have the right to challenge." Drew. Dep. at 140:23-25. Mr. Waldman's unilateral decisions leak Confidential material make a mockery of this Court's Order.

**III. Mr. Waldman Created Witness Declarations with this Case Header, Leaked them to the Press Falsely Purporting to Have Filed the Declarations in this Court, and Provided Other Discoverable Materials to the Press While Refusing to Produce to Defendant**

Throughout this case, Mr. Waldman has leaked discoverable documents to the press without producing them to Defendant, forcing Defendant to move to compel and the Court to Order the leaked material be produced, and despite those documents being responsive to Court-Ordered discovery but not produced. These leaked documents included audio recordings and surveillance pictures, along with at least eight Declarations from third party witnesses that were leaked to websites and twitter users without being produced despite their responsiveness and covered by Orders compelling production. News outlets to which Waldman leaked these documents referred to them as "court documents,"<sup>2</sup> leading readers and potential jurors to believe that these Declarations are somehow official case documents, which they are not.<sup>3</sup>

Plaintiff – we believe through Mr. Waldman as well –also leaked numerous discoverable materials through Twitter to launder information that Mr. Waldman apparently believes will help Plaintiff. For example, on April 6, 2020, a Twitter user posted a video with a title containing

“NEW EVIDENCE!!!” that includes Declarations (with case captions for this matter in Fairfax County) from third parties as well as medical records from Gold Coast University in Australia regarding Mr. Depp’s finger injury.<sup>4</sup> Plaintiff leaked these medical records without producing them to Defendant despite the Court’s October 18, 2019 Order compelling their production.<sup>5</sup> It wasn’t until after Defendant moved to compel on July 10 and the Court re-Ordered Plaintiff to produce these records that he actually did so – 10 months late and after public disclosure.

Mr. Waldman has leaked numerous other documents to Twitter users and gossip websites before producing them to Defendant, including: A personal email and attachment of Ms. Heard’s to a Twitter user, who posted it on December 14<sup>6</sup>; text messages from Ms. Heard’s parents to Mr. Depp<sup>7</sup>; correspondence between an attorney for a non-party witness who sought confidentiality protections in advance of the witness’s deposition<sup>8</sup>; excerpts of audio of a 2015 recording between Mr. Depp and Ms. Heard;<sup>9</sup> and excerpts of a 2016 audio recording between Mr. Depp and Ms. Heard.<sup>10</sup> Mr. Waldman appears more intent on leaking and violating the Protective Order than in complying with his client’s discovery obligations, the Court Orders on prior motions to compel, and following the Court’s directive not to litigate the case in the press. *See*,

e.g., Dec. 13, 2019 Hr'g Tr. 6:20-22 (Court: "[W]e don't need to make statements and arguments that are later on going to be used in the press. So we're going to just stop doing that.").

Mr. Waldman's continuing efforts to manipulate the press and disregard discovery obligations are wholly improper and fundamentally at odds with Ms. Heard's rights to a fair trial and full and fair discovery. See, e.g., *Am. Sci. & Eng'g, Inc. v. Autoclear, LLC*, 606 F. Supp. 2d 617, 625–26 (E.D. Va. 2008) (awarding sanctions for a misleading press release and recognizing "[t]he Supreme Court has held that civil litigants have a constitutional right to an impartial jury [and] [c]ourts may disallow prejudicial extrajudicial statements by litigants that risk tainting or biasing the jury pool.") (internal citations omitted). They also impede the willingness of third parties to participate in this case for fear of leaks or harassment by Mr. Waldman. See *supra* n. 8. Indeed, after Mr. Waldman leaked his deposition testimony, Joshua Drew initially stated that he would not testify in the UK trial. The Court should put a stop to this conduct.

#### **IV. Mr. Waldman's Tweets and Press Statements Show No Regard for Judicial Process**

Mr. Waldman is a prolific tweeter and publicity hound whose tweets and press releases about this case generally fall into three categories: (1) statements that refer to leaked documents that have not been produced (**Exh. 4**); (2) statements that show utter disrespect for the judicial process and the Court's admonitions not to litigate this case in the press (**Exh. 5**); and (3) *ad hominem* attacks on Ms. Heard or her counsel (**Exhs. 6 and 7**). The Court need only take a cursory glance at the representative samples Defendant has attached to conclude that Mr. Waldman fails to meet "the level of professionalism . . . that our [C]hief [J]ustices. . . as well as many others in the [S]tate have worked so hard to instill." 273 Va. at 522.

#### **CONCLUSION**

For the reasons above, Defendant respectfully requests that the Court grant the Motion.
