Background Information
HCAB Meeting, November 9, 2020

Reston Hospital Community Report. On September 14, 2009, a public meeting was held to review a rezoning application submitted on behalf of Reston Hospital Center for the purpose of expanding its medical campus. At that time, Reston Hospital agreed to appear annually before the HCAB to inform the Board of medical needs and challenges in the Reston area.

Adult Day Care Amendment Update. Zoning Administration Division staff will be returning to HCAB to discuss the revised approach for regulating adult day care programs that provide support services for individuals with intellectual and developmental disabilities distinct from the adult day care center use currently contained in the Zoning Ordinance. This proposal is in response to concerns previously raised to the proposed Zoning Ordinance Amendment that was discussed at the May 11, 2020 HCAB meeting. This revised approach has been incorporated into the Zoning Ordinance Modernization (zMOD) project.
