During the 2nd quarter of Fiscal Year 2020 the Planning Commission acted on **60** applications; affording 21 citizens an opportunity to speak in person at the 11 public hearings held. The districts with the highest number of applications considered were the Hunter Mill and Springfield Districts with 11 applications acted upon.

Land Use Process Review Committee

Met on October 23, 2019, with Clarion Associates for a Zoning Ordinance Modernization presentation on progress regarding the modernization of the Zoning Ordinance by updating the County's development standards, parking, signs, and zoning districts.

Met on November 7, 2019, with Fairfax County Land Development Services (LDS) staff for an update on the LDS proposed Fee Schedule amendments and the LDS Phase 2 Flex project. The Department of Planning and Development Zoning Administrator along with LDS staff provided an update on the proposed Zoning Ordinance Amendment for Regional Mall Parking Rate.

Transportation Committee



Schools Committee

The committee voted to recommend to the Planning Commission approval of the draft recommendations regarding shared County and School Comprehensive Plan priorities. The Planning Commission voted to approve the recommendation at the January 8, 2020 meeting.
