Background

Throughout 2023, representatives from the International Association of Fire Fighters (IAFF) Local 2068 and Fairfax County negotiated an initial collective bargaining agreement (CBA). The CBA contained a provision allowing "...any member in active service who is a uniformed member of the FRD..." to purchase active-duty military service.

Prior to formal approval of the CBA by the Fairfax County Board of Supervisors (December 5, 2023), the Fairfax County Retirement Systems (FCRS) contacted Cheiron (FCRS's actuary) to determine the actuarial cost to members looking to purchase the applicable service credit. According to the CBA, "Regardless of the method of payment, the member shall be responsible for paying the full costs of the service credits, including any increase in cost due to the timing of payments."

An actuarial tool (i.e., Service Purchase Calculator) was created and thoroughly tested to ensure accurate calculation of the cost for purchasing service credit. Subsequently, tables reflecting **Service Purchase Cost Estimates** (see page 3) were compiled by FCRS and shared via memorandum with representatives of the Uniformed Retirement System (URS)(e.g., Board of Trustee member(s)) for distribution to employees of the retirement system.
