Dear Delegate Krizek,

The Northern Virginia Soil and Water Conservation District (NVSWCD) promotes sustainable urban and suburban activities and stewardship to conserve our soil, water, air, plants, and animal resources in Fairfax County. These are vital components of the Chesapeake Bay Watershed. We achieve this through effective leadership, technical assistance, and outreach programs in partnership with government, industry, non-profit organizations, and the public.

Invasive plants wreak havoc in many landscapes, causing problems for all Virginians, regardless of their place of residence across the Commonwealth. Biologists studying invasive species across the United States estimate they cause \$120 billion in annual economic losses. The list of damages includes lost crops, devastated timberlands, diseased plants, and expensive management and removal costs. Some invasive species can be poisonous to livestock and cause human illnesses. In Virginia alone, the Department of Conservation and Recreation estimates that costs associated with invasive plants and animals may reach \$1 billion annually.

The Virginia Association of Conservation Districts adopted a policy in December 2021 to support a study of invasive plant species in Virginia and subsequently offer recommendations to reduce or eliminate the sale of invasive plants in the commonwealth and instead promote the sale of native plants.

Consistent with that policy, the NVSWCD endorses the following bills that have been introduced in the General Assembly, and referred to the House of Delegates Committee on Agriculture Chesapeake and Natural Resources: HB311 - Delegate Krizek, HB314 - Delegate Krizek, HB491 - Delegate Bulova.

We believe these three bills represent significant positive steps forward and deserve to become law. We urge the House of Delegates and the Senate to promptly pass these bills and send them to the Governor for his approval.
