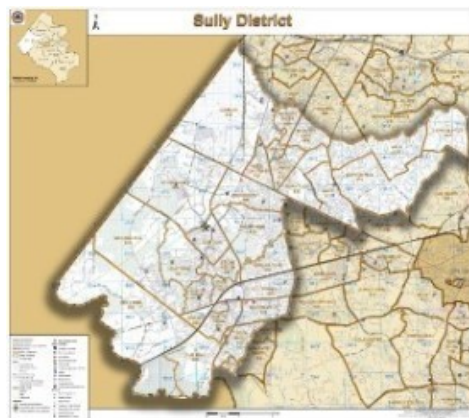

Inoperable Vehicles on Private Property



The Traffic Division of the Fairfax County Police Department (FCPD) has an Impound Officer who responds to residents' complaints about inoperative (junk) vehicles that are on private property. The [Fairfax County Code, Chapter 110](#) - Inoperative Motor Vehicles, Trailers and Semitrailers, regulates the storage of inoperative vehicles on private property.

Violation of Chapter 110 is a Class 2 misdemeanor, subject to a fine, and towing and storage costs as applicable. Inoperative motor vehicles are defined in Section 110-2-1(3) as: not in operating condition, or do not display valid license plates, or do not display a valid inspection decal, or does display an inspection decal that has been expired for more than 60 days.

The FCPD Impound Officer, after first seeking voluntary compliance with a warning, will issue a Notice of Violation. If the Notice of Violation is disregarded, criminal enforcement action is taken, and the vehicle is towed. Complaints about expired vehicle license plates and safety inspections decals are investigated if expired for at least six months. Barring unusual circumstances, inoperable vehicle complaints usually are resolved within 90 days of the report.

Fairfax County Opens Two New Donation Stations

On October 9, 2019, Fairfax County opened new Donation Stations at the [I-95 land-fill complex](#) in Lorton and the [I-66 transfer station](#) in Fairfax. Both locations are open seven days a week, from 8:00 a.m. to 4:00 p.m.

Donation Stations provide another option for residents to divert material from the waste-to-energy plant and landfills. Reducing waste by repurposing unwanted, but usable, goods is an important part of the county's integrated waste management strategy.

Attendants at the Donation Stations help residents unload items and provide a receipt for the donations. The collected items are prepared for sale in local thrift shops. Textiles that are no longer serviceable are recycled into carpet, upholstery, and other uses. Residents with unaccepted items can dispose of them in a different area of the site.

Accepted items include:

- Clothing, shoes, hats, outerwear, and accessories
- Toys and games
- Books
- Records and CDs
- Household items, such as toasters, glassware, dishes, and cookware

Donation Stations do not accept:

- Car seats, cribs, playpens
- Bike helmets
- Food, plants, pets
- Lawnmowers, swing sets
- Items that are broken or missing pieces
- Electronics
- Propane or fuel containers
- Weapons

Pilot Program to Remove Litter from Waterways

Fairfax County has launched a new pilot program that will help improve water quality in streams and provide dignity in work to people experiencing homelessness. Started October 1, the 12-week program provides part-time, temporary work to guests of the Eleanor U. Kennedy Community Shelter, Bailey's Crossroads Community Shelter, and The Lamb Center, and helps the county meet its mandate to keep streams clean. Participants will earn \$10 an hour to pick up litter in and around streams and to remove invasive plants. The pilot is modeled after The Lamb Center's successful [City Jobs program](#), a partnership with the City of Fairfax.

Staff from the county's Stormwater Planning Division will identify litter hot spots, and the non-profit operators of the shelters, New Hope Housing and The Lamb Center, will vet participants, provide transportation, supervise their work, track and report the number of bags of litter that are filled during each outing, and provide a hot meal after each four-hour shift. Participants will be provided with high-visibility vests, gloves, trash grabbers, nets, insect repellent, sunscreen, and trash bags. The Solid Waste Management Program will collect and dispose of the full bags of litter.

The pilot program is funded by the [Stormwater Service District fee](#), established by the Board of Supervisors in 2010 to support environmental mandates, such as those that protect local streams and the Chesapeake Bay.
